STATEMENT OF PARTICULARS OF CLAIM

The plaintiff claims the balance of \$1,350.00 for money lent by the plaintiff to the defendant at her request which the defendant has failed to repay to the plaintiff despite demands. (see Annexure)

The plaintiff claims the amount set out below and elects to have this claim heard and decided in the Magistrates Court under the simplified procedures as a minor debt claim -

TO THE DEFENDANTS:

TAKE NOTICE that you are being sued by the plaintiff in the Court. If you intend to dispute this claim you must within 28 days of service upon you of this claim for a Notice of Intention to Defend and Defence to a Minor Debt Claim in this registry. If you do not comply with this requirement, judgment may be given against you for the amount claimed without further notice to you. The notice should be in Form 4 to the *Uniform Civil Procedure Rules*. You must serve a sealed copy of it at the plaintiff's address for service shown in the claim as soon as possible.

If you object that these proceedings have not been commenced in the correct district or that this Court does not have jurisdiction in this matter, that objection should be included in your Notice of Intention to Defend and Defence to a Minor Debt Claim.
